INFORMATION:

MEDIA - The show is open to all types of arts and crafts. All work must be original, hand-crafted, and exhibitors must sell their own work only. Items made with kits or resale items are not allowed.

GENERAL - Each exhibitor will have approximate space of 10 x 10. Exhibitors are to supply their own display material as well as tables, chairs. Exhibitors can set up a 10 x 10 tent if they wish. There is no electric available and generators are prohibited. Each exhibitor is responsible for the set-up, care, take-down of their own booth. **All tents must be secure and weighted down.**

Exhibitors must be set up and ready and vehicles removed by the start of the Show. Late set up is not allowed. **No vendor tear-downs are allowed until 2:00 p.m.**

Entrance to the set up area is off of Park Lane. Volunteers will be in the lot to direct you to your space.

In the event that the field is too wet for set up, the Show will be held and we will set up in the Park Lane Parking Lot. If this is the case, participants will not be allowed to park vehicles in the lot. Parking is available at Borough Hall (4 W Lancaster Avenue) and the Kerr Park parking lot off of Wallace Avenue.
