**A RESOLUTION SETTING PARKING FINES; DESIGNATING
BOROUGH PARKING LOTS AND DAILY RATES FOR PARKING**

WHEREAS, from time to time it is necessary for the Borough of Downingtown (the "Borough") to set parking fines, designate Borough parking lots and set daily rates for parking in the Borough; and

WHEREAS, the Borough is authorized by 75 Pa.C.S.A. §6109(a)(1), (b)(1), to regulate parking within the Borough; and

WHEREAS, the Borough Code, 53 P.S. §1202(2) provides the Borough with the general power to regulate charges in the operation of, inter alia, parking lots; and

WHEREAS, the Borough Code, 53 P.S. §1202(3), provides the Borough with the general power to impose fines and penalties for the violation of its ordinances and regulations; and

WHEREAS, the Borough Code, 53 P.S. §1202(46), provides the Borough with the general power to acquire and regulate parking lots within the Borough; and

WHEREAS, the Borough Code, 53 P.S. §1202(74), provides the Borough with the general power to make and adopt all such ordinances, bylaws, rules and regulations not inconsistent with or restrained by the Constitution and laws of this Commonwealth, as may be expedient or necessary for the proper management, care and control of the borough and its finances, and for the maintenance of peace, good government, safety and welfare of the Borough and its trade, commerce and manufactures.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Downingtown, County of Chester, Pennsylvania that:

1. All fines for violation of Borough parking ordinances shall be \$15.00 per violation if paid within seven (7) days of issuance of the notice of violation or parking ticket as the case may be, and \$20.00 per violation thereafter.
2. The following parking lots shall be established in the Borough of Downingtown:


- a. Bradford Avenue Lot
- b. Viaduct Avenue Lot
- c. Stuart Avenue Lot
- d. West End Lot
- e. Central Lot
- f. Park Lane Lot
- g. Mill Alley Lot
- h. Washington Avenue Lot
- i. Beech Street Lot
- j. East End Lot
- k. Marinelli Park Lot
- l. Kerr Park Lot
- m. The Ponds Lot

3. Unless otherwise clearly identified, the daily rates for the Borough's parking lots shall be as follows:

- a. Bradford Avenue Lot, \$1.00 per day
- b. Viaduct Avenue Lot, \$1.00 per day
- c. Stuart Avenue Lot, \$0.50 per hour
- d. West End Lot, \$0.50 per hour & permit parking
- e. Central Lot, \$1.00 per day
- f. Park Lane Lot, \$1.00 per day & permit parking
- g. Mill Alley Lot, \$0.50 per hour
- h. Washington Avenue Lot, permit parking

- i. Beech Street Lot, \$0.50 per hour
- j. East End Lot, \$1.00 per day (when metered, the rate will be .25 per 15 minutes)
- k. Marinelli Park Lot, permit parking
- l. Kerr Park Lot, free parking
- m. The Ponds Lot, free parking


